APPLICATION TRANSFER ACKNOWLEDGEMENT**

TRANSFEROR AND TRANSFEREE ACKNOWLEDGE AND AGREE THAT (I) THE FACEBOOK APP TRANSFER SERVICES WILL BE PROVIDED ON AN “AS-IS” BASIS AND WITHOUT ANY EXPRESS OR IMPLIED WARRANTIES BEING GIVEN BY FACEBOOK, INCLUDING, BUT NOT LIMITED TO, THE IMPLIED WARRANTIES OF MERCHANTABILITY, FITNESS FOR A PARTICULAR PURPOSE, INTEROPERABILITY AND NON-INFRINGEMENT AND (II) FACEBOOK BEARS NO RESPONSIBILITY AND WILL NOT HAVE ANY DIRECT OR INDIRECT LIABILITY TO TRANSFEROR, TRANSFEREE, OR THIRD PARTIES FOR ANY LOSSES, DAMAGES OR OTHER ISSUES TRANSFEROR, TRANSFEREE, OR THIRD PARTIES MAY HAVE OR INCUR AS A RESULT OF OR ARISING FROM THE FACEBOOK APP TRANSFER SERVICES OR ANY OTHER MATTER RELATED TO THIS ACKNOWLEDGMENT.
